- IV. Approval of the Agenda Added principal's report. Chester makes motion, Samantha seconds. Unanimously approved.
- V. Public Comment The Board received thank you notes from staff for Teacher Appreciation Week.
- VI. Principal Report Linda Spreitzer asked for representatives at graduations and relayed the roof will be done the last week of May.  - a. Technology Request

Isaac Korgan delivered a quote for 71 one-year warranties and 184 2-year warranties for Chromebooks. The cost would be \$13,780 for all warranties from Bluum and would come from the 2023-24 budget. Carl made a motion to approve the purchase of 71 one-year and 184 2-year warranties for the cost of \$13,780. Second by Tish. Unanimously approved.

Discussion about iPads.

- Laptops tether teachers to the front of their room, so iPads allow for classroom management and movement.
- Kindergarten would need 60 iPads next year. F

- 26 for tech, 10 for art, 12 for music, 26 for staff.
- Cost of \$40,912.

Chromebooks were ordered, as were music computers and a front-office computer.

Tish makes a motion to purchase 74 iPads from Apple at a cost of \$40,912.80. Seconded by Sara. Unanimously approved.

b. Kitchen Appliances

c. Lottery Software
